

# LINDEN POSTCARD SHOW 2020-21

## TERMS & CONDITIONS

Before submitting your works to the Linden Postcard Show, please read these Terms & Conditions carefully. If your works do not meet the entry specifications, as stated in the Terms & Conditions, they will not be included in the exhibition. Entry fee refunds will not be provided if your work does not meet the specifications outlined below.

- > All artworks must measure 8 x 10 inches (20.32 x 25.4cm) exactly including framing
- > You can enter up to 3 works
- > Artworks on paper must be framed
- > Artworks without a secure hanging system will not be included in the exhibition.
- > Artworks must be completed in 2020
- > We accept 2-dimensional or 3-dimensional artworks with a depth of up to 10cm if they can be hung on the wall only. We do not accept video or freestanding sculptural works.
- > All entries to the Linden Postcard Show must be completed online via [www.gallery247.com.au](http://www.gallery247.com.au), Visit our Online Entry Step by Step Guide for assistance.
- > Artworks entered into the prize via the gallery247 website must be the same as the works received for display.
- > Artworks cannot be removed and artwork prices cannot be changed during the exhibition period.
- > This prize is only open to Australian residents.
- > By entering this prize artists are confirming they are the creator and owner of the entered work(s) and have not breached copyright in the creation of the work
- > Failure to comply with any of the above will make an entry ineligible
- > Placement of the works in the exhibition is at the Curator's discretion.
- > Multiple artworks or series by one artist may not be hung together.

### **DUE TO COVID-19 RESTRICTIONS**

- > All artwork must be posted to Linden New Art and cannot be delivered in person – this will allow us to disinfect all the packaging and have the artworks at the gallery for up to 72 hours prior to installing the exhibition. This will reduce the risk of transmission of the virus for our staff.
- > There will be no public opening for this year's show. Instead we will host a virtual opening and announce the winners online on Friday 4 December 2020.

### **ENTRY FEES**

- > \$44 for one work, \$55 for two works and \$66 for three works including GST
- > Entry fee(s) are non-refundable and cover administration, return postage and handling

### **ENTRIES CLOSE**

- > midnight Tuesday 20 October 2020
- > The number of entries will be capped at 1000 artworks. These places may fill up before the entry deadline.

### **ARTWORK MUST ARRIVE BY POST**

- > Between Monday 26 October - Friday 6 November 2020

### **EXHIBITION DATES**

- > OFFICIAL OPENING – Friday 4 December 2020, 6PM-7:30PM – prizes announced from 6.30PM (VIRTUAL ONLY)
- > OPEN TO THE PUBLIC – Saturday 5 December 2020
- > CLOSES – Sunday 31 January 2021

## **RIGHT TO REFUSE TO DISPLAY ARTWORKS**

Linden New Art reserves the right to refuse to display artwork if it:

- > Does not meet entry requirements
- > Is not exactly 8 x 10 inches in size including framing
- > Poses safety risks
- > Under normally accepted standards, could be considered offensive in terms of pornographic content, character denigration, racial or religious prejudice
- > In any way does not comply with Linden's policies and procedures.

## **COPYRIGHT AND REPRODUCITON OF IMAGES**

- > Entrants agree to allow Linden New Art to reproduce (at no charge) images of entered artwork in all publicity and promotion of the Linden Postcard Show, subject to Linden's discretion. This does not affect the copyright status of the work.
- > Images of the finalists' artwork will be published on Linden's website and social media sites including but not limited to Instagram, Facebook, Twitter & Flickr.

## **JUDGING**

- > The judges will award all prizes and their decisions are final and no correspondence will be entered into.
- > Prizes will be announced on opening night, Friday 6 November 2020 6.30pm. The People's Choice Award will be announced at the end of the exhibition.

## **SALES**

- > All works must be for sale.
- > The price of the artwork is set by the artist.
- > All sales attract a 30% sales commission plus GST. For example, a \$100 artwork sale will attract a commission of \$30 plus GST to Linden. Linden receives \$33 & the artist receives \$67.
- > All payments to artists for sold work are made by Direct Deposit. Please ensure your current bank account details are provided on your Gallery 247 profile page. Payments will be processed within 21 days of sale.
- > Once artworks have been entered into the Postcard Show, they must not be for sale on the gallery247 website, until after the close of the show.

## **POSTAGE AND INSURANCE**

- > The delivery of artworks to the Linden Postcard Show is at no cost to Linden New Art.
  - > All artworks are packaged for return to artists or buyers by Australia Post at no additional cost to the artist (this is covered by the entry fee). They are returned within 14 - 21 days after the completion of the exhibition.
  - > Linden will not be held responsible for any loss or damage caused to any work while in transit to and from the gallery.
  - > All artworks will be handled by experienced staff. However, fragile works will be entered at artist's own risk.
  - > Linden's insurance will cover works whilst on display at the gallery.
- Please ensure that you contact gallery staff if you move from the address provided. If you are going to be away in February 2021 please ensure you have a hold on your post so that no packages go missing.

## **VISITING THE GALLERY**

- > Due to COVID-19 restrictions Linden must manage the number of visitors to the gallery each day. Visitors must make a timed booking prior to their visit.
- > Artworks can be purchased in person at the gallery or over the phone.
